Within 10 days we must receive a signed contract and a negotiated non-refundable deposit, or the date will not be held. The deposit securing the booking is forfeited if the function is cancelled for any reason, unless the specified date and time are rebooked with another function of equal or greater size. ♦ A final count with the exact number of menu choices will be required 7 days prior to the function. The client is also responsible for paying for any additional guests served above this minimum guarantee. ♦ Final arrangements (ie. choice of menu, estimated count, number of guests at head table, etc.) must be made at least 14 days in advance. ♦ The restaurant does not assume responsibility for the damage or loss of any merchandise or article left in the banquet facility prior to, during or following the function. ♦ All special arrangements are subject to approval. ♦ Decorations and/or displays may not be attached to wall, doors, windows or ceiling. ♦ All food and beverage items remaining from your function cannot be removed from the premises. ♦ We reserve the right to refuse alcoholic beverage service to any guest at the function who is under 21 years of age and/or limit the consumption of any guest, for the safety and comfort of everyone. ♦ The person signing the contract will be responsible for any damage to the premises caused by any guest. ♦ Private dining room maximum capacity is 30 people.
